- I. Call to Order. Mayor Bart Jetton called meeting to order at 6:00 P.M.
- II. Roll Call. Council members absent: Amanda Willows. Council members present: Brandon Thomas, Stacey Nichols and Patricia Wood. Also present: Mayor Bart Jetton, Mayor Pro Tem Joey McCarthy and City Secretary Tricia Smith taping the minutes.
- III. **"PUBLIC HEARING"**- Discuss/take action on City of Reno's proposed budget for Fiscal year 2018-2019. Mayor Jetton opened public hearing at 6:03 P.M. No one present to speak. Public hearing closed at 6:05 P.M.
- IV. **"BUDGET WORKSHOP"** – Council to discuss budget for Fiscal Year 2018-2019. Council discussed. No action taken.
- V. Business-Discuss/Take action on:

Wood, to approve budget amendments and purchasing a nozzle in the amount of \$700.00. Motion carried 4-0.

- g. Approve quote from Casco in the amount of \$5,319.00 to purchase bunker gear for RVFD. Council member Thomas moved, with a second from Council member Wood, to approve quote from Casco in the amount of \$5,319.00 to purchase bunker gear for RVFD. Motion carried 4-0.
