- I. Call to Order. Mayor Bart Jetton called meeting to order at 6:06 P.M.
- II. Invocation. Led by Tony Vanderwilt, Pastor of Cornerstone Baptist Church.
- III. Pledge of Allegiance to United States and Texas Flags.
- IV. Roll Call. Council members absent: Amanda Willows. Council members present: Patricia Wood, Brandon Thomas and Stacey Nichols. Also present: Mayor Bart Jetton, Mayor Pro Tem Joey McCarthy, City Attorney David Hamilton and City Secretary Tricia Smith taping the minutes.

- VIII. **“PUBLIC HEARING”**- to consider a re-zone request part of A888 J SKIDMORE, TRACT 62, ACRES 1.214, within the Corporate Limits of the City of Reno, County of Lamar and State of Texas, from R-1 Residential to B-1 Commercial; as requested by Deanna Nicholson, owner. Mayor Jetton opened public hearing at 6:09 P.M. No one signed up to speak. Public hearing closed at 6:09 P.M. Mayor Pro Tem McCarthy moved,

with a second from Council member Nichols, to approve the zone change as requested. Motion carried 4-0.

IX. Business-Discuss/Take action on:

- a. Monthly Citizen/Business recognition for the City of Reno. Council member Patricia Wood selected Wendell Kinslow to be the distinguished citizen for November 2019.
- b. Request for construction of 100 ft. antenna for internet/microwave antenna at 5820 Old Clarksville Road, as requested by Tony Vanderbilt. Mayor Pro Tem McCarthy moved, with a second from Council member Thomas, to approve the request for construction of 100 ft antenna for personal use up to 120 feet. Motion carried 4-0.
- c. Approval of construction on temporary plats on Ashton Lane and Brittany Lane, as requested by Rodger Price, developer. Council member Thomas moved, with a second from Mayor Pro Tem McCarthy, to approve construction on temporary plats on Ashton Lane and Brittany Lane. Motion carried 4-0.
- d. Street and drainage repairs to Old Clarksville Road. Public Works Supervisor Jerry Reavis, presented bids to Council for drainage repairs to Old Clarksville Road. Mayor Pro Tem McCarthy moved, with a second from Council member Nichols, to send bids to the Street Commission for their recommendation.
- e. Appointment to vacant seat on the Planning and Zoning Commission. Council member Thomas moved, with a second from Council member Nichols, to appoint David Wood to the Planning and Zoning Commission. Motion carried 3-0 with Council member Wood abstaining.
- f. Resolution for Park and Trail Grant. Council member Thomas moved, with a second from Council member Nichols, to approve resolution for Park and Trail Grant up to \$100,000.00. Motion carried 4-0.
- g. Reno's Winter Wonderland Christmas Festival. No action taken.
- h. Participation in Paris Christmas Parade. Mayor Pro Tem McCarthy moved, with a second from Council member Nichols, approve participating in the Paris Christmas Parade December 7, 2019. Motion carried 4-0.
- i. Annual evaluations for the City Secretary, Police Chief, Public Works Supervisor and City Attorney. Mayor Pro Tem McCarthy moved, with a second from Council member Thomas, to table evaluations until next months regular meeting. Motion carried 4-0.
