- I. Call to Order. Mayor Bart Jetton called meeting to order at 6:00 P.M.

- IV. Roll Call. Council members absent: Amanda Willows and James Dority. Council members present: Brandon Thomas and Stacey Nichols. Also present: Mayor Bart Jetton, Mayor Pro Tem Joey McCarthy, City Attorney David Hamilton and City Secretary Tricia Smith taping the minutes.

- c. Replacing headstone for Richard Bills and proper disposal of original headstone. Kirstin Dodd, with Sunflower Cemetery Services explained to Council that you can only have one marker in the cemetery at a time. Council member Thomas moved, with a second from Mayor Pro Tem McCarthy, to approve replacing the old headstone with the new one. Motion carried 3-0.

Mayor Pro Tem McCarthy moved, with a second from Council member Thomas, to approve revisions to Article 4.03 Vendors, Canvassers, Door-To-Door Sales and vendor applications, as for food trucks and vendors for city events, the fee will be excluded. Motion carried 3-0.
