- I. Call to Order. Mayor Jetton called meeting to order at 6:01 P.M.
- II. Invocation. Led by David Hamilton.
- III. Pledge of Allegiance to United States and Texas Flags.
- IV. Roll Call. Absent: Council member Amanda Willows. Council members present: James Dority, Stacey Nichols and Brandon Thomas. Also present: Mayor Bart Jetton, Mayor Pro Tem Joey McCarthy, City Attorney David Hamilton and City Secretary Tricia Smith taping the minutes.
- V. THE ITEMS IN THIS AGENDA MAY BE DISCUSSED AND VOTED ON IN ANY ORDER THE PRESIDING OFFICER MAY PREFER.
- VI. Citizens may issue comments for topics that do not appear on this agenda. In accordance with existing law, the City Council cannot discuss, deliberate or take action on any item or topic that is not so scheduled on this agenda.  - Council member Nichols moved, with a second from Council member Thomas, to approve consent items as presented. Motion carried 4-0.
- VIII. **"PUBLIC HEARING"** Discuss/Take action on a re-zone request of a part of A853 West Skidmore Survey, Tract 27, Acres .963, 6810 Pine Mill Road, Reno Texas, from R-1 Residential to MF-1 Multifamily, as requested by Kelly Millsap, owner. Public hearing

opened at 6:06 P.M. Kenneth and Kelley Millsap, 6180 Pine Mill Road, addressed Council requesting this zone change. Mr. Millsap stated his plans are to remove the trailer that is there and build duplexes. Mr. Millsap also stated that he would be willing to put up a privacy fence. James Proctor, 6815 Pine Mill Road addressed Council stating that he is against the zone change. Kendra Proctor, 6815 Pine Mill Road expressed her concerns regarding crime in the area and possible future zone changes in the future. Mrs. Proctor stated she is definitely against this zone change. Patsy Rodgers, 6725 Pine Mill Road stated she is not in favor of the zone change or duplexes. Mrs. Rodgers stated this neighborhood doesn't need to look like Anderson Road. Mrs. Rodgers also stated she is also concerned about her property values. Deanna Nicholson, 6940 Pine Mill Road said her property values will go down, because duplexes decrease value. Mrs. Nicholson also stated the park is very important to this community and duplexes aren't a good fit, and she is against this zone change request. Public hearing closed at 6:19 P.M. Council member Thomas moved, with a second from Council member Nichols, to deny zone change. Motion carried 4-0.
