- b. Update from Mike Tibbets with Hayter Engineering regarding the Standpipe project. Mike Tibbetts from Hayter Engineering, explained to Council that the standpipe is in service, and the contractors also built a building with installation to go around some of the piping. Mr. Tibbetts also stated that all of the paperwork has been submitted, and he recommends making the final payment to Tankez in the amount of \$34,550.00. Council member Willows moved, with a second from Council member Skidmore, to submit final payment to Tankez in the amount of \$34,500.00. Motion carried 4-0.

- c. Proposed Asphalt Street Specifications. Jerry Reavis, Public Works Supervisor presented the Proposed Asphalt Street Specifications from Hayter Engineering. Jerry Reavis explained that the Street Commission reviewed these and recommend approving these specifications from our engineers.
