- I. Call to Order. Mayor Heuberger called meeting to order at 6:00 P.M.
- II. Invocation. Given by Mayor Pro tem Rick Jordan.
- III. Pledge of Allegiance to United States and Texas Flags.
- IV. Roll Call. Council members present: Ruth Ashmore, Mike Chapman, Stacey Nichols and Jerry McFadden. Also present Mayor William Heuberger, Mayor Pro tem Rick Jordan, City Attorney, David Hamilton and Assistant City Secretary, Tricia Smith taping the minutes.
