- I. Call to Order. Mayor Heuberger called meeting to order at 6:00 P.M.
- II. Invocation.

- IV. Roll Call. Council members present: Ruth Ashmore, Jerry McFadden, Walter Cooper and Stacey Nichols. Also present: Mayor William Heuberger, Mayor Pro tem Rick Jordan, City Attorney David Hamilton and City Secretary Cara Hubbard taping the minutes.

  - a. Consider approval of a resolution authorizing the suspension of the proposed effective date of the proposed rate schedules of the Mid-Tex Division of Atmos Energy. Tim Gilbert with Atmos Energy addressed the Council regarding the suspension of the proposed effective date of the proposed rate schedules of the Mid-Tex Division of Atmos Energy.
