MINUTES

- I. Call to Order. Mayor Heuberger called meeting to order at 5:00 O.M.
- II. Roll Call. Absent: Jerry McFadden. Council members present: Ruth Ashmore, Stacey Nichols and Walter Cooper. Also present Mayor William Heuberger, Mayor Pro tem Rick Jordan and City Secretary Cara Hubbard taping the minutes.
- III. **EXECUTIVE SESSION-** The Council may enter into closed or executive session to discuss the following:
 - a. Texas Government Code Sections 551.074 (Personnel Matters)
 1. The Council will meet in Executive Session to consider possible personnel action involving the police sergeant for the City of Reno. The Council will hear charges and accusations, and may deliberate on the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of the police sergeant for the City of Reno.
 2. This Executive Session will also serve as the Section 1.601 disciplinary hearing for the police sergeant for the City of Reno regarding the May 2012 suspension with pay, the allegations which for the basis for that suspension, and employment, reassignment, discipline, or dismissal.
