- I. Call to Order. Mayor Heuberger called meeting to order at 6:00 p.m.
- II. Invocation. Led by Mayor Pro tem Rick Jordan.

- IV. Roll Call. Absent: Council member Stacey Nichols. Council members present: Mike Chapman, Walter Cooper, and Joey McCarthy. Also present: Mayor William Heuberger, Mayor Pro tem Rick Jordan, City Attorney David Hamilton and City Secretary Cara Hubbard taping the minutes.

- VII. New Business-Discuss/take action:
  - a. Accept annexation petition for 4884 Haning, as requested by Alden George, property owner. Council member Chapman moved, with a second from Council member McCarthy, to accept annexation petition for 4884 Haning as requested by Alden George. Motion carried 4-0.
  - b. Sewer at 5805 Jamar Road as requested by Lynda Allen, owner. Bill Flanary, 1116 Lamar, addressed Council concerning sewer problem. No action taken.
  - c. Authorize staff to issue a Request for Proposals for Performing Building Inspections for the City of Reno. Mayor Pro tem Jordan moved, with a second from Council member Chapman, to authorize staff to issue a request for proposals for performing building inspections for the City of Reno. Motion carried 4-0.

Motion carried 4-0.
- b. Street bids for Pine Mill Road and Old Clarksville Road as recommended by Street Commission. Council member Chapman moved, with a second from Council member Cooper, to accept recommendation from Street Commission and accept bid for Pine Mill Road from Drake Construction Company in the amount of \$68,400. Motion carried 4-0.
- c. Contract with Lamar County Water. Council entered into executive session at 6:45 p.m. Council returned to open session at 7:11 p.m. No action taken.
