Motion carried 4-0.
- b. Agreement for mutual aid in fire protection between the City of Paris, Texas and Reno Volunteer Fire Department Reno, Texas. Council member Chapman moved, with a second from Council member Nichols, to adopt Resolution No. 811.3. Motion carried 4-0.
- c. Contract and pending litigation with Lamar County Water.
