- I. Call to Order. Mayor William Heuberger called meeting to order at 6:00 P.M.
- II. Invocation. Led by Mayor Pro tem Rick Jordan.

- IV. Roll Call. Council members present: Joey McCarthy, Brandon Thomas, Walter Cooper and Amanda Willows. Also present: Mayor William Heuberger, Mayor Pro tem Rick Jordan, City Attorney David Hamilton and Assistant City Secretary Tricia Smith taping the minutes.

Council member Cooper moved, with a second from Council member Thomas, to approve consent items as presented. Motion carried 5-0.

VIII. New Business-Discuss/Take action on:

- a. Architect/Engineer selection process for city hall office/public works expansion. Mayor Pro tem Jordan moved, with a second from Council member Willows, to proceed with architect and engineer selection process beginning with local architects. Motion carried 5-0.
- b. Engineer selection process to prepare plans and specifications for water meter upgrade project. Council member Thomas moved, with a second from Council member Willows, to proceed with the process to prepare plans and specifications for water meter upgrade project with our city engineer. Motion carried 5-0.
- c. Budget amendment for Law Enforcement Training. Council member McCarthy moved, with a second from Council member Thomas, to approve budget amendment for Law Enforcement Training. Motion carried 5-0.
- d. City logo patches including cost and patch limits. Mayor Pro tem Jordan moved, with a second from Council member Thomas, to remove the dollar amount from previous motion and provide maximum of 3 patches per year for Employees, Council, Board members, Committee members and all volunteers, to use on shirts or jackets of their choice. Motion carried 5-0.
- e. Water and Sewer for property on the south side Old Clarksville Road at Airport Road, in accordance with an annexation agreement. Council member McCarthy moved, with a second from Council member Cooper, to table this item until property owners take some kind of action or make a move. Motion carried 5-0.
- f. Reno Volunteer Fire Department retirement benefit. Mayor Heuberger tabled this item until we can get a representative from the Texas Emergency Services Retirement System (TESRS) to present a presentation.
- g. IT support for city computer system. Chief Birch presented IT Support proposals to Council. Council member Thomas moved, with a second from Mayor Pro tem Jordan, to authorize approval of contract with TSM Consulting Services for \$1,500.00 per month, contingent upon funding being found in the current fiscal year budget in the proper accounts and the proposal does include \$250 for email within the \$1,500.00 monthly fee and off site back up is included. Motion carried 5-0.
- h. Old equipment/surplus items to be auctioned through Rene Bates' on-line auction service. Council member Willows moved, with a second from Council member Cooper, to approve to put old equipment surplus items to be auctioned through Rene Bates Auction Service. Motion carried 5-0.
- i. Update from police chief on status of hiring the additional officer approved in the 2014-15 budget. Mayor Pro tem Jordan moved, with a second from Council member Cooper, to update the city of Reno policy manual to remove 1 year experience requirement for police officer, require certification only. Motion carried 5-0.
- j. Update on status of sewer customers on Smallwood that can be served by new sewer line installed one year ago. No action taken.
