**MINUTES**

1. Call meeting to order. Chairman Ronnie Nutt called meeting to order at 6:00 P.M.
2. Roll Call. Commissioners present: Troy Scholl, Wendell Kinslow and David Brooks. Also present: Chairman Ronnie Nutt, Public Works Supervisor Jerry Reavis and Assistant City Secretary Tricia Smith taping the minutes.
3. Approval of the Minutes from the June 1, 2015 Street Commission meeting. Commissioner David Brooks moved, with a second from Commissioner Troy Scholl, to approve minutes as presented. Motion carried 4-0.
4. Discuss/make recommendations regarding Smallwood Road repairs as requested by Richard Stauter. Mr. Stauter 2550 Meadow Lane addressed the Commission requesting repairs for one half mile section of Smallwood Road between Wildwood Lane and Meadow Lane. Commissioner David Brooks moved, with a second from Commissioner Troy Scholl, to recommend getting bids to repair a half mile section of Smallwood Road, from Meadow Lane to Wildwood Lane. Motion carried 4-0.

5. Discuss/make recommendations regarding bids for Town East, Vicksburg, Sleepy Hollow and Old Clarksville Road. Public Works Supervisor Jerry Reavis discussed bids with the Street Commission.

Commissioner David Brooks moved, with a second from Commissioner Wendell Kinslow, to recommend Option 1 from Drake Construction, to repair Vicksburg in the amount of \$6,045.00. Motion carried 3-0.

Commissioner Wendell Kinslow moved, with a second from Commissioner David Brooks, to recommend accepting bid from Drake Construction in the amount of \$9,455.00 to repair Town East. Motion carried 3-0.

Commissioner David Brooks moved, with a second from Commissioner Wendell Kinslow, to recommend accepting bids from Drake Construction to repair Twin Lakes in the amount of \$4,006.00. Motion carried 3-0.

Commissioner David Brooks moved, with a second from Wendell Kinslow, to recommend accepting the following bids from Drake Construction to repair Old Clarksville Road: Area B in the amount of \$4,469.00 and Area C in the amount of \$21,635.00. Motion carried 3-0.

7. Discuss/make recommendation regarding drainage priority list. No action taken.
8. Discuss fiscal year 2014-2015 budget. No action taken.
9. Discuss/make recommendations regarding vacant position. No action taken.
