- IV. Roll Call. Council members present: Joey McCarthy, Brandon Thomas, Tom Brandenburgh and Amanda Willows. Also present: Mayor Bart Jetton, Mayor Pro tem Rick Jordan, City Attorney David Hamilton and Assistant City Secretary Tricia Smith taping the minutes.

Recommendation from Planning and Zoning to grant an ordinance variance at 5440 Lamar, as requested by Larry and Staci Young owners; regarding Chapter 14 *Zoning*; Section 5.001 Setbacks and Lot Sizes (a) Setbacks: (3) Side Street-Corner lots shall have both street exposures treated as front yards. Council member McCarthy moved, with a second from Council member Thomas, to follow recommendation from Planning and Zoning to approve a three foot variance on the west side of 5440 Lamar, as requested by Larry and Staci Young owners. Motion carried 5-0.
- b. Consider approval of Resolution No. 513.12: Ordering Election. *La resolución numero 513.12: elección de orden*. Council member Thomas moved, with a second from Council member Willows, to approve Resolution No. 513.12: Ordering Election. Motion carried 5-0.
- c. Request for proposal from Hayter Engineering for a new Public Works Building. Public Works Supervisor Jerry Reavis addressed Council explaining he needs Council approval to be able to move forward. Council member Thomas moved, with a second from Council member Willows, to request proposal from Hayter Engineering for a new Public Works Building. Motion carried 5-0.

- e. 2015 Racial Profiling report. Police Chief Birch presented 2015 Racial Profiling Report to Council. Council member McCarthy moved, with a second from Council member Thomas, to approve 2015 Racial Profiling Report. Motion carried 5-0.
- f. Proposal to revise the overtime and holiday policy. Council member Thomas moved, with a second from Council member Brandenburgh, to add in Section 3.5 Overtime, Compensation Time and Time Management, under nonexempt employees, in third paragraph, down, add regardless whether the hours are on a holiday or on a normal workday, all hours worked are used to calculate overtime; Section 4.1: Holidays on page 49 strike out the last sentence which is "neither paid holiday time nor holiday work time are calculated for purposes of the 40 hour work week and/or overtime compensation permitted under this policy or under federal or state law. Motion carried 4-1 with Mayor Pro tem Jordan opposing.
- g. Update on Keep Reno Beautiful. Council member Willows updated Council on Keep Reno Beautiful Program. No action taken.
- h. Update on Union Grove Cemetery. City Attorney David Hamilton addressed Council explaining that the deed has been filed, the money has been transferred and the cemetery now belongs to the City of Reno. No action taken.
